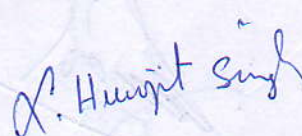
MINUTES OF THE 30th SENATE MEETING HELD ON 21st July, 2023

ITEM NO. 30.8: Discussion on the 5th Journal Verification committee meeting held on 02/01/2023

1. Discussion about Ms. Victoria Ningthoujam (Full Time):

Ms. Victoria Ningthoujam (18401004) under the supervision of Dr. Romeji, Associate Professor, Civil, NIT Manipur will complete 4 years on 17/01/2023. Maximum duration of a full time PhD scholar is 6 years.

Ms. Victoria Ningthoujam has one paper in Scopus journal (accepted for publication) and has published 3 conference papers.

Recommendation by JVC: Ms. Victoria Ningthoujam has still enough time to complete 6 years. She should publish at least one more SCI/SCIE journal paper.

After threadbare discussion and deliberation on the recommendation of 5th Journal Verification committee meeting, the Senate approved that Ms. Victoria Ningthoujam should publish at least one more SCI/SCIE journal paper.

2. Discussion about Mr. Thiyam Samrat Singh (Full Time)

Mr. Thiyam Samrat Singh (15PCH004) under the supervision of Dr. Th. David Singh, Associate Professor, Chemistry Department, NIT Manipur has already completed 7 years including 1 year extension on 06/12/2022. Maximum duration of a full time PhD scholar is 6 years.

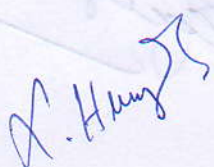
Mr. Thiyam Samrat Singh has published 2 Scopus journal papers, 1 Google indexed journal paper and 1 conference paper.

Recommendation by JVC: Mr. Thiyam Samrat Singh does not have enough time; however he has already published 2 Scopus journal papers, 1 Google Indexed journal paper and 1 conference paper. He may be allowed to submit his thesis.

Moreover, the 28th Senate meeting held on 17/03/2023 vide its Item No. 28.11 resolution has extended for submission of PhD thesis of Mr. Thiyam Samrat Singh till 30/06/2023 as a special case failing which his registration will be cancelled.

After threadbare discussion and deliberation, the Senate in reference to 28th Senate meeting resolution enquired whether Mr. Thiyam Samrat Singh has submitted the Thesis by 30/06/2023.

On the query, the HoD apprised the Senate that the above PhD scholar has not submitted his thesis till date due to the prevailing unrest situation in the state.



Taking into consideration the prevailing situation in the state and the career of the PhD scholar, the Senate directed that Mr. Thiyam Samrat Singh should submit his thesis by 31/08/2023.

ITEM NO. 30.9: Discussion on the 6th Journal Verification committee meeting held on 21/04/2023

1. Discussion about Mr. Ngangom Robertson (Full Time)

Mr. Ngangom Robertson (15PCE001) under Prof. Oinam Bakimchandra, Civil Engineering Department has completed 8 years 3 months on 21/04/2023.

He has published 1 Scopus journal paper in "Global Journal of Environmental Science and Management. He has presented two conference papers.

Resolution by JVC: Mr. Ngangom Robertson may be allowed to take 6 months extension from 21/04/2023 to publish at least one SCI/SCIE.

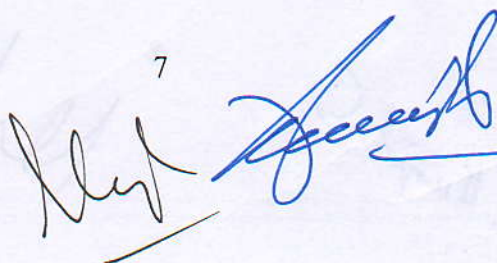
2. Discussion about Ms. Arpita Chatterjee (Full Time)
